#5 Mr. Duckmans culvert needs cleaning. Mr. Schwerman will be instructed to do this work.

#6 Pigs on Mr. Druly's are polluting the stream which flows into the Lake.

Make report on these subjects before the second Sunday in August to Miss. Bake.

At this time the committee of three returned with Mr Prechel who withdrew his resignation, and will continue as Chairman and Director of this Organization.

Mr. Moeloth made a motion that Mrs. Buckleys attorney write a letter to Mr. Druly about his pigs polluting the Lake and his dog killing other dogs in this community.

This motion was seconded by Mr. Kreuser.

To discourage the entrance of outsiders, who are not Guests of Property Holders, Mr. Brault made a motion to have as Policman at the Main Entrance Gate on Sundays, Between the hours of II A.M. and 7 P.M.

Mr. Mueller seconded this motion, and it was carried unanimously by the Board of Directors.

It was decided by the Board of Directors that Le Roy Volling be given this job.

Le Roy has aggreed to work 8 hours, for \$2.50 .

De Cals or Plates were discussed as a tag for Forest Lake automobile owners.

Mr. Prechel said he would obtain a price on these tags.

Miss Bake made a motion that we with the help of A.T. Mc Intosh & Co., eliminate eye Sores, such as "resident tents", "out houses", "trailers", Etc., Etc.

This motion was seconded by Mr. Thorsen, and carried.
