citizens of the United States, propose to form a corporation under an Act of the General Assembly of the State of Illinois, entitled, "An Act concerning Corporations," approved April 18, 1872, and all Acts amendatory thereof; and for the purpose of such organization we hereby state as follows, to-wit:

1. The name of such corporation is FOREST LAKE CORPORATION

2. The object for which it is formed is to form a body of men thoroughly representative of the business and professional interests of Forest Lake. To promote a mutual interest in the government of said community. To encourage an active cooperative and non-profit participation in all things that have to do with the economic, educational, commercial, recreational, civic and industrial development of the community hereinafter referred to as Forest Lake, as defined and described on plat of said territory which was filed and recorded on May 17, 1935 in the office and records of Lake County, State of Illinois. To mutually protect the class interests of the community that involve problems of appearance, health, sanitation and property.

No dividends or distribution of the property of such corporation shall be made until all debts are fully paid and then only upon its final dissolution and surrender of organization and name; nor shall any distribution be made except by a vote of a majority of the members.

3. The management of the aforesaid FOREST LAKE CORPORATION shall be vested in a board of fifteen (15) Directors.

4. The following persons are hereby selected as the Directors to control and manage said corporation for the first year of its corporate existence, viz:

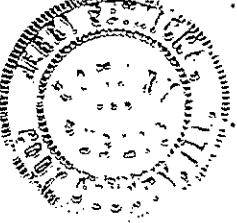

2. That the purpose shown in the Certificate of Incorporation be stricken out and and the following purpose inserted: 53 AUG 15 '40 33

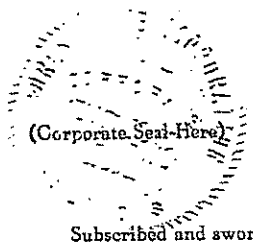
