Annual Due-Due

No, not yearly fertilizing (that's the job of this newsletter), but notice that the annual dues are about to be mailed. If

you're reading this and don't see an invoice for 1998's assessment (\$80.00) by October 31, please call Pat Lynn (438-0859) or Steve Norman (540-8857).

Once again, these dues are used to maintain the lake, parks, and other common areas and to pay for liability insurance (every homeowner in Forest Lake is liable if a tragedy should occur at one of our beaches). Further, you must be a dues paid member to use F.L.C.A. property (parks, lake, etc.). In the near future we will be exploring ways to have the Sheriff's office enforce these rules (i.e.: let the Sheriff keep all the money from trespassing fines) and we will be contracting with a towing company to remove any car without a current sticker from the parking lots at the beaches and the Community Center.

Your dues include one car sticker. Each additional car sticker is \$1.00, boat stickers are \$5.00, and a key to the boat launch is \$1.00.

These dues/fees offer a better return on investment than any stock market ever could!

No-Show Boats

Due to the fact no one checks with us when they move out of Forest Lake and the fact people move to communities without lakes; boats are often simply left behind or abandoned. Some boats at our parks may not even belong to residents. Therefore boats without any stickers were removed during the Spring Clean-Up. Boats with 1996 stickers were left TEMPORARILY as people may have simply forgotten to affix their new 1997 stickers.

Again a reminder regarding boat park-

ing at the beaches (better late than never):

ALL boats MUST have a current sticker or they will be removed.

On the South and West beaches, they MUST be parked prow (the front end) in, abutting and locked to the fence along the sides of the parks. Violators will be removed.

At the Luttrell Park boat launch (by the tavern), boats must be locked to the cable running along the ground West of the beach area.

NO boats should be chained to trees, bushes, etc. The Central (East side) Beach has NO boat parking. Periodically, throughout the year, illegally parked boats will be cut loose and moved. This is for safety as well as aesthetic reasons so

Therefore, let it be known (and this serves as official notification): ALL boats on FLCA property without 1997 stickers, will be removed in November so get your stickers in place or Michael won't be rowing the boat ashore any time soon. Also, boats which were removed during Spring Clean-Up must be claimed by October 31 or they'll be scuttled.
