THAT BURNING FEELING

For those who choose to stay in Forest Lake and rake the leaves left by our remaining trees; yard waste (clippings, grass, leaves, in-laws, etc.) is picked up on Friday's via a special truck from April through November. Waste must be in the requisite bags (which can be purchased from local hardware stores) with a special sticker attached. These stickers cost \$1.00 apiece and can be bought at Lake Zurich Disposal (just North of Quentin and Route 22) or mailed to you on request by calling 438-6763 and they'll appear on your next invoice.

And PLEASE, don't burn leaves in the streets. These avenues are narrow, lack sidewalks, and the smoke is worse than any fog ever seen in London and with the resultant loss of a lane caused by the pyres, a VERY dangerous situation is created. Pedestrians, children playing, and oncoming cars often cannot be seen in what remains of the street. So PLEASE burn YOUR leaves on YOUR property or bag them as noted above (better hurry, though, as November is almost gone). Keep in mind this subdivision was designed for a few hundred cars and we now have well over a thousand so please be aware (unless, of course, you want to hand over your house keys to some litigator).

HOLD THAT BOAT!

Contrary to previously published dribble, boats are NOT supposed to be chained to fences any longer. Apparently, they were never supposed to be chained there and adjoining property owners have simply been kind enough not to shoot any naval interlopers.
