## **Development Around Forest Lake:**

The property immediately to the east and south of Forest Lake will be developed soon. The Community Association is monitoring the development of the property adjoining Forest Lake. Attend the next meeting for information about what is happening.

## **Waste Management:**

Waste Management has been asked which recyclables should be put into our recycling bins. Waste Management recycles number 1 through 7 plastics but no styrofoam, pizza boxes or packaging materials such as styrofoam "peanuts" or bubble wrap. They take aluminum cans but no vinyl or aluminum siding. All paper and cardboard is recycled. Remove the plastic bags from cereal boxes. Cardboard boxes must be broken down and cut into 2' X 2' squares or smaller. Cardboard may be tied with string. Bottle glass is the only type that is recycled. The truck picks up everything put in the bins but it has to be separated out at the recycling center.

## **Boat Stickers:**

All boats on Forest Lake must have an FLCA boat sticker. Stickers may be purchased with

your dues. Boat stickers are limited to 3 per household.

FLCA meetings are held on the second Tuesday of each month at 7:30 in the Community Center. All members of the association are invited to attend.

## **Our Community Center:**

Our recently remodeled Community Center is located at the intersection of East and South Roads in the southeast corner of Forest Lake and is available for rental to all paid Association members.

The rental fee is \$185.00 with refundable \$250.00 deposit. Prospective renters must appear at an Association Board meeting at least a month prior to the event and payment (both rental and deposit) is due one (1) month prior to the rental. The deposit check is not cashed, but held until after the event.

Rental includes use of the building, the parking lot, basketball court, park, and baseball diamond for the day. The building has two (2) bathrooms (one of which is fitted for the handicapped), a full wet bar and a full kitchen with appliances. There are no pots, pans, silverware, utensils, etc. Folding tables (which seat eight) and chairs are included.
