Fertilizing on our watershed

Most of our subdivision drains into Forest Lake. If you fertilize your lawn, try to use the minimum amount of fertilizer and please do not fertilize near the lake. Nitrogen is one of our largest problems in the water. Nitrogen causes weed and algae growth well beyond its natural expectations. I know that it is hard for some of us to hold back but please be frugal when you fertilize. Also be aware that most lawn herbicides and insecticides are toxic to fish and other aquatic life.

Swimming and Fishing

Only FLCA members and their guests are allowed to fish or swim in Forest Lake. Members must accompany guests when they are in our parks or on the lake.
