\$6,740,000

That is how much Lake County Forest Preserve District paid for the new Heron Creek Forest Preserve. Heron Creek is located at the intersection of Rt22 and Old McHenry Rd. It contains sensitive wetlands, the south branch of Indian Creek and oak/hickory woodlands. It is adjacent to the Reed Turner Nature Preserve. If you haven't visited Reed Turner, the entrance is on Old McHenry Rd. in Long Grove. It is a beautiful walk any time of the year. Take advantage of one of the beautiful nature areas near our community. We are looking forward to the development of Heron Creek and its proximity to Forest Lake.

Did you know that our elevation is 810 feet, our land area is .6 miles and our median resident age is 36.6 years? Our latitude is 42.21 N, Longitude is 88.05W. Community Center Rental

Our Community Center is located in the Southeast corner of Forest Lake. It is available for rent by our members.
