## **Flooding**

Bill Kruckenberg, Ela Twp. Road Commissioner, attended the March FLCA meeting to discuss storm water runoff. Bill is working on the flooding problem on Valley. The drain tiles are about 70 years old and were probably destroyed when the sewers were installed 20 years ago. He also met with homeowners along Lakeside, Valley, Shady and Forest about installing curbing to deflect the flow of water from their homes. A 4" concrete curb will be installed at selected problem areas. The repaving of the streets will start in 2008 and, because of rising cost of blacktop will take 2 to 3 years to complete.

Discussion was had about the reduction of the 50ft. setback on Shady Lane and its impact on flooding in that area. It is our understanding that a motion was filed by Pam Newton to reduce the setback to 30ft., as the feeling was the 50ft. setback was too restrictive.

Mike Talbot, our County Board Representative, listened to some of our flooding problems. He

pointed out that the problems were caused when Forest Lake was developed in 1935 and they should have been rectified then. Since they weren't, they are not the responsibility of Lake County. Federal grant money is available to help improve drainage and reduce flooding. Limited funds are available and the first step is to fill out an application, including a description of the project. If anyone is interested in filling out an application for a federal grant, Mike Talbot would send the grant application to the appropriate federal agency.

## What goes in, stays in

Development can decrease the recharging of groundwater by increasing the impermeable surface area with buildings, roads and driveways. Instead of rainfall infiltrating into the aquifer, it runs off to lakes and streams. The storm water from roofs, driveways, parking lots and streets contains contaminants such as gasoline, oils, metals, road salt and bacteria which will end up either in our ground water, lake or streams. Fertilizers applied to lawns and other plants may also leach into our groundwater while the phosphorus may run off into our lake and streams. Any gasoline, oil, or chemical spills may, over many years, seep into our drinking

water aquifer. It is important that we clean up spills and not pour leftover insect killer, fertilizers and chemicals in the corner of our backyards. SWALCO has hazardous waste pickup at designated locations throughout the year. For further information check out SWALCO.org. They will also take leftover paint and electronics on designated days.
