The lake, Community Center and all parks are to be used by members and guests that are accompanied by a member. Do not tell your friends that they can use our properties unless you are current with your dues and are accompanying them for their entire visit.

Please bring your Beach Pass with you each time you use our lake and parks. Board members and residents will randomly be checking passes. If you do not have one, you will be asked to leave. If the problem continues with non-members using our properties, the Lake County Sheriff will be called and trespassing charges will be filed.

Parking

If your neighbor is parking their boat or car on the lawn or parking on the street in front of their house, call the Lake County Sheriff (847-549-5200) and they will take care of the problem.

Fertilizing Your Lawn

Please do not use any fertilizer containing phosphates on your lawn or garden. This is listed on the back of the bag. Phosphates are washed into our lake as well as Kemper Lake and cause aquatic weed and algae growth. Aquatic weeds have been a major problem in Forest Lake over the years and we don't want to have another weed problem. If you have a commercial company apply fertilizer, ask them to use a fertilizer that does not contain phosphates.

Rain Garden

Jill Hughes is applying for a grant for a demonstration rain garden to be put in at either Erker Park or Kaiser Park. A rain garden is designed to collect rainwater in a low area and allows it to seep into the ground rather than run off into the lake or a stream. The rain garden is planted with perennial flowers and grasses. If you are interested in developing a rain garden in your yard, call Jill.

Garden Walk

If you are interested in organizing a Forest Lake garden walk, come to the next board meeting and bring your ideas. There are quite a few beautiful flower gardens in Forest Lake that many of us would be very interested in visiting.

Rain collected after a thunderstorm contains nitrogen, an excellent plant fertilizer.
