Additionally, we urge everyone to return all fish to the lake so you and others can enjoy catching them again.

Landscape Improvements

The planting bed around the sign at Quentin and Highland received some much needed renovation recently. Existing plants were dug up, new dirt was added, and the sedums replanted. Purple asters, yellow coreopsis, and blue spring-blooming scilla were added. The ornamental grasses were removed, to improve driver visibility at that intersection. Be Sure You Have That Boat Sticker

Recently Illinois Conservation Department police visited Forest Lake and issued tickets for unregistered boats and boats with missing life preservers. If your pontoon, rowboat, paddleboat, kayak, canoe, etc. is not registered with the State and you do not have the proper number of approved life preservers, you are subject to a fine. Also, all boats operating after dark must have lights.

Waste Management

Ela Township has signed a contract with Waste Management and all unincorporated areas in the township are included. You should have received 2 bins, one for recycling and one for garbage. If the garbage bin is larger than your recycling bin and you would like a smaller one, call Waste Management (800/796-9696). There should be no extra charge for this (they will typically waive the "extra fee.") If you are over 65 you can also apply for a senior citizen discount. Ela Township's contract also eliminates our Tuesday summer pickup. Bill Krukenberg has reported to us at a recent meeting that the garbage trucks take a toll on the asphalt and with only one pickup in the summer, our streets will last longer.

Heron Creek

Heron Creek Forest Preserve is now open! At our last meeting Bonnie McLeod, of the Lake County Forest Preserve District, presented an overview of nearby forest preserves, the newest of which is Heron Creek, at the intersection of Old McHenry Road and Route 22. They Are Here!

Unfortunately, gypsy moths have found their way west and were recently discovered in Forest Lake. They can strip your trees of leaves and stress a tree to the point that even the healthiest trees may die in two years. The best thing that you can do is look around your yard on the trunks of your trees and bushes, your lawn furniture and under your deck for their egg sacks. Remove them and destroy them. Danger! Thin Ice!

Don't forget to check the thickness of the ice before walking on it or allowing your children to walk on it. The ice should be at least 5 inches thick to support a small group of people on the ice. Drill a hole with a portable drill and check the depth. If it is not thick enough, stay off. The ice is thinnest at the mouth of the 3 streams that run into the lake. Be especially cautious around them. They freeze last and thaw first.
