- F. Lake Report Nick Leonard
 - Nick presented the new annual report from the Lake Committee. This excellent report summarizes the findings of the Lake County Environmental Health Services reports, the Volunteer Lake Monitoring Program, and the actions that have been taken to improve and maintain the lake. The report provides a detailed set of goals for continued improvement and makes recommendations to achieve those goals. The report will be posted to the FLCA website and all are encouraged to read it. A big "Thank You" to Nick Leonard, Lou DiNicola, Todd Thomas, and Larry Steker for their work on the report!
 - We are planning some targeted education programs on shoreline erosion.
 We hope to receive assistance from EHS in the form of educational materials to be mailed to the shoreline property owners.
 - The board feels that it is imperative that FLCA's properties along the lake exhibit best management practices in shoreline erosion control. We are investigating new methods (such as "coco logs") to stabilize the shoreline at the north park.
 - The board authorized the sum of \$620 payable to Lake County EHS for a targeted monitoring of the three primary inlets and the outlet of the lake. The water will be monitored May-September this year for Total Phosphates (TP) and Total Suspended Solids (TSS). The data will provide a better understanding of the dynamics of the lake and help determine future actions. (Motion by Norman/Libby)

 - All the arborvitae shrubs have survived the winter.
 - The entrance signs are in the process of being refurbished.

The board authorized the attorney to spend no more than three billable hours to investigate this and advise us. (Motion by Norman/Hughes)

As a result of a recent issue, the board has decided that we will not expunge past dues for prospective renters in the future. If the renter can afford the rental fees, they can afford to pay <u>all</u> of their past dues.
