I. Call to Order

- F. Lake Report Nick L.
 - Geese abatement strings have been installed at the beaches. They seem to be effective. March-June and September-November are high-activity times for geese. If we elect to hire a swan service, the package is \$2,500/year.

- We experienced another beach closure, this time at Central Park. The water tested OK the next day. The very high level of bacteria that was tested is suspect. When the sample was taken, three ducks were observed in the water. Members asked about the safety of the water in the middle of the lake. We are only required to provide testing of the designated swimming areas.
- Water quality is still good. Though clarity was 6' in May/June, it is down to more typical levels (2 ¹/₂') for this time of year. Aquatic plant diversity is improving.
- G. Parks Report Pat D.
 - The Board asked Greg to consider taking over as the chair of the parks committee. He will discuss this with Pat.
 - Tree trimming was completed. The board approved the expenditure of up to \$500 to trim/remove four dying trees along South Road. (Motion by Tegtmeier; Norman)
 - To avoid future confusion, please coordinate Winkleman's activities through Greg.
 - Greg to talk to Winkleman about the sand at the beaches. There are reports that Erker received fresh sand, but not the other beaches. Nick & Greg will determine the best places to add sand.
 - Greg & Nick will also evaluate the slope and gravel at the boat ramp to determine the course for improvement.
 - The swings at the park were lubricated.
- H. Landscape/Beautification Report Maija B.
 - Nothing to report.
- I. Legal/Insurance Report Steve G.
 - Insurance quote will be coming shortly.
