 - Nick has spoken to County about environmental issues (erosion) on the La Haie property. A broken drain tile is causing much of the erosion.
 - Lake County is performing an on-foot survey of the watershed to provide greater accuracy. Initial reports are that more land is included in our lake's watershed than was previously thought.
 - Nick re-iterated that the turquoise color on the lake surface this past summer was blue-green algae (*not* copper sulfate, as some rumors said).

 - The team is looking into locking down the port-o-potties to reduce vandalism (tipping).
