- F. Lake Report Nick L.
  - It is reported by Leonard that the lake is doing well. Recent rains have affected the flouridone levels and a bump application was needed. C.L.P.W. is gone. We will not need another bump application because it is late in the season. Other plants are growing well. The water temperature is down and that is good. It is reported that phosphorus levels are up because of plant decomposition. Disc tests indicate 3.5' to 4' visibility. Those numbers are good. Leonard to investigate phosphorus laws and our roll in implementing them. It was reported that most of the phosphorus in the lake comes from outside sources and not from the lake plants. It is reported that Tower Lakes is dredging their lake. Rumor has it that it is costing residents an extra \$250.00 in addition to their dues for the next 5 years.
- G. Parks Report Greg D.
  - It is reported by Dwiel that normal park and footpath maintenance continues. Plans for Central Park are continuing and will have more information at next meeting. Swim ropes need to be reinstalled at Erker Park and Dwiel will call McHenry Pier. Erker Park flower beds need weeding and Dwiel will call Winkelmann.
