- A. Chairman's Report Hughes
  - Residents will be able to opt out of ComEd as their electrical service provider and potentially get better pricing than the Lake Zurich agreement through a negotiated Ela Township arrangement. Notice to arrive in the mail shortly.
  - Community Center has been rented for a LZ High School Football kickoff event this Saturday the 17<sup>th</sup>. Rental agreement was signed and key to facility was given to renter, rental fee was waived.

  - Lots of weeding has been done all year.
  - Need to discuss cost of park maintenance in new business

- I. Legal/Insurance Report Norman
  - Norman will look at old contract of purchased material for entrance signs and report back at next meeting
  - Slight increase in insurance costs but nothing out of the norm. Liability insurance was discussed and importance of paying dues to fall under FLCA policy. Norman will provide article for newsletter highlighting this.
