## History

Forest Lake was developed in 1935 by Arthur T. McIntosh. A 40 acre lake was carved out of the ground three miles east of Lake Zurich. Lake Zurich was a prime vacation area for workers in Chicago the PLZ & W) railroad was built 1912-1924 from Palatine to Wauconda). McIntosh saw a need for a subdivision that supported vacation homes for the families coming from Chicago so he created Forest Lake and subdivided the area for homes. After WWII, Forest Lake provided an ideal setting to start raising a family. In 1961, the community saw a need to build a community center and raised money for the building. Over the years we have added a storage room, changed the roof from a flat roof to a gable roof and remodeled the interior to accommodate the needs of our members.

With the help of a federal grant and a lot of work from the board, sewers were added in 1983. Every street was dug up, sewer lines added and the roads rebuilt the following spring.

Your membership dues have made it possible to maintain our 5 parks and pathway easements, community center and lake.



## Summer Fishing Derby

It's a great way to meet neighbors, regardless if you fish or not! But if you just can't wait for the details, here they are: THIS YEAR WE ARE EXCITED TO ADD SHORELINE FISHING. We will have mobile fish checkin boats to measure your whoppers caught from private docks. Those without access to private lakefront fishing can use the North park. Fishing is not allowed at any of the other three parks (west, south or central). If seen fishing at any of the other parks you will be asked to leaved and forfeit all fees. It will be held Saturday, June 29<sup>th</sup> 6am to 6pm with registration starting at 5:30am. Registration is at North beach or from boat it's at south end of lake. ## Rumor?

The conservation police have been around again checking state registration, life jacket count on boats (including canoes and kayaks) and fishing licenses. Make sure that you are prepared. They will return.

All watercraft other than non-powered watercraft on the waters within the jurisdiction of this State shall be registered and titled. New this year: Canoes, kayaks and paddle boats are no longer required to be titled/registered in Illinois UNLESS they have a motor or sail; otherwise customers will be able to purchase a 'Water Usage Stamp' for \$6.00 per calendar year for the first three vessels and \$3.00 for any additional vessels, all passes must be purchased at the same time to receive the discount. Water Usage stamps are mandatory. They should be available, over the counter, at any point-of-sale vendor starting July 1, 2013.

## Creel Limit

Forest Lake does have a limit on the quantity and size of fish that may be kept. Shore fishing is only allowed by members and their accompanied guests at the North Beach.

Walleye Pike - 14"
Northern Pike - 24"
Muskellunge - 36"
Bass - 14"
Pan fish - any size
Catfish - 14"
Carp - No limit - Please remove any carp that you catch.

## Weed Spraying

There have been reports of dead fish, most of which seem to be crappie. There is no indication that the dead fish are due to the curlyleaf treatment with fluridone. Fluridone has been shown to be safe for fish at the concentration being used. The dying plant matter can consume oxygen and lower dissolved oxygen levels in the water, which can result in fish kills but the oxygen concentration is well above the desired level. Because most of the fish are crappie, the deaths appear to be crappie specific, perhaps a disease of some sort. The situation will continue to be monitored.
