No Wake Zone

As powerboats are getting larger and the motors more powerful and dangerous to swimmers, the board has voted to make all of Forest Lake a "No Wake" zone.

If you are swimming, be aware that boat operators may have trouble seeing you, especially in the evening. We encourage swimmers to wear a fluorescent headband when outside the buoyed areas.

All boats that are used on Forest Lake or are stored on

FLCA property must display a 2014 FLCA sticker. Stickers may be purchased when paying your dues, at a meeting, or by contacting Steve Norman: 540-8857. Boats stored at our parks that do not have a current sticker may be removed from our property and disposed of.

Fishing Regulations

Forest Lake has a limit on the quantity and size of fish that may be kept. Creel Limit:

- 1 Walleye Pike 14"
- 1 Northern Pike 24"
- 1 Muskellunge 36"

3 Bass - 14" 10 Pan fish - any size 2 Catfish – 14" Carp – No limit - Please remove all carp

Boats that have been in other lakes must be washed thoroughly with soap to remove aquatic plants and animals (zebra mussels and curly leaf, for example) before they are launched.

Fishing by members is allowed from private boats, piers, and at Luttrell Park (north end of lake) only, not from any beach area.

Dogs are allowed at Luttrell Park only.

If you have not paid your current dues, you may not use our lake, beaches or parks. You are trespassing on private property.
