The minimums for keeping fish caught in the lake are:

- 1 Walleye Pike 18"
- 1 Northern Pike 18"
- 1 Muskellunge 36"
- 3 Bass 14"

10 Pan fish

1 Catfish - 14"

Carp – No limit - Please do not release back into the lake
