#### **Leaf Disposal This Fall**

Leaves, acorns, and other yard waste can significantly contribute to the high nitrogen and phosphorous levels in Forest Lake. When you're cursing the blanket of leaves in your yard this fall, The Forest Lake Improvement Committee (FLIC) asks that you please consider your impact on the lake, particularly if you live on or near the shoreline or an inlet.

#### Composting

Composting your leaves is a great way to remove your leaves by turning them into high quality fertilizer for your garden. You can learn more at sites like www.goodcompost.com.

#### Bagging as Yard Waste

Bagging your leaves and disposing them through curb side pick-up completely removes their nutrients from the lake's watershed. Waste Management offers yard waste disposal for an additional \$2 a month from April through November. Also, some leaf blowers have a mulching function which can decrease the overall volume of leaves by more than half.

#### Mulching

Thoroughly mulching your leaves with a mulching lawnmower decrease their ability to get into the lake, and will also act as a natural fertilizer for your lawn.

# **Burning leaves**

Burning leaves has the largest negative impact on the lake. Burning breaks down the leaf structure and makes the nutrients readily available (no decomposition necessary) for excess algae and plant growth. Burning leaves at the curbside, close to the shoreline or close to an inlet gives the ash a direct path to the lake. Burning leaves along the street is illegal in Lake County and will result in a fine. DO NOT BURN AT THE CURBSIDE OR CLOSE TO THE SHORELINE OR AN INLET. Also, consider disposing the cool ash in the garbage to remove the nutrients from the lake's watershed.

# <u>DO NOT blow leaves directly into the lake or into the street</u>

Leaves blown into the street <u>will</u> end up in the lake. The decomposing leaves create bottom "muck" and excess nutrients to the water. More than enough leaves end up in the lake from the wind - please don't add anymore.

Please do your part to keep Forest Lake beautiful!

### **FLCA Dues**

In a Community Association, every member of the association (the homeowner) is responsible for their small part of keeping the organization up and running efficiently by paying their association dues in a timely manner.
