Lake Notes

Zebra Mussels have spread extensively in the Great Lakes region in the past decade and have made their way into Forest Lake. They attach themselves to any solid underwater object such as boat hulls, pontoons, piers, rocks and even other zebra mussels. They may look harmless, but *Zebra Mussel shells are very sharp* and can easily cut hands and feet. We suggest wearing water shoes when swimming at the beaches or sand bar. Please avoid picking them up or pulling them off of objects as well.

Beaches and Parks

Only members of the FLCA and guests accompanied by members are allowed on any property owned by the FLCA. This includes Forest Lake itself as it is a private lake. Our parks and beaches are patrolled regularly as we have people from near and far, as well as

non-members, who want to swim, picnic, boat and fish in our lake.

All watercraft used and stored on Forest Lake must have a FLCA boat sticker. Please affix 2018 stickers on your boats and cars so they are visible. We are constantly monitoring watercraft stored and used on the lake. If you have not paid your 2018 dues and have a watercraft at a park, remove it or it will be removed. Watercraft stickers are available to all FLCA members. Costs are \$5.00 for non-motorized watercraft and \$25.00 for motorized watercraft. Also, **we will be placing Coyote decoys** at the beaches in another attempt to deter the geese. The geese have been especially troublesome this year as many were herded out of Kemper for their PGA event. **Please do not remove or let your children play on them.**
