Lake Report (Leonard): Lake's been better. Struggling with blue-green algae. Had record-setting clarity thanks to zebra mussel infestation.

Phosphorous levels may not be a big contributor to algae blooms. Let it be and the algae passes on its own. There are 40 types of blue-green algae and we don't have the worst. There is no quick fix, it's just a bad year. The fish seem okay, though. Should post signs at beaches only when it's really bad. There is phosphorous embedded in the lake bottom which sometimes rises. The county comes by every week to test.

Curly leaf and zebra mussels were probably brought in by a boat through Lutrell. We are now shutting down Lutrell until we get a workable plan in place to prevent further invasions. Only Greg and Nick can now open the gate. For now, at least, boats entering must win on dry land for at least two weeks. A formal plan will be prepared and presented.

Parks (M. Vormittag): Bug trees down and cleaned up.

Landscape/Beautification Report (Boriss): Nothing.
