Word on The Street ...

Unfortunately, it's continued complaints about people who drive wrecklessly or don't have any consideration for others on the road. Let's nip this in the bud! If you are unsure of the meaning of signs with the words STOP, YIELD, SPEED LIMIT or NO PARKING, please visit cyberdriveillinois.com and download your free copy of the Rules of the Road. This publication should help you immensely.

If you haven't noticed, Forest Lake has narrow streets and no sidewalks. The 25 MPH Speed Limit is much too fast, please adjust your speed when you see pedestrians or just slow down in general. Due to the snow, our roads are even narrower and icy as well. There are children and pets playing in yards and in snow that may be close to the road.

Be alert and slow down.

We also ask that anyone walking, running or bicycling wear bright/reflective clothing and carry a light. Please make pets visible too. We want everyone to be safe out there!



Winter Fun on Forest Lake

Summer isn't the only time to enjoy Forest Lake! Winter brings skating, sledding, ice fishing, dog walking, snowmobiling, hockey and even ice golf. All great fun, but please remember to play it safe when on the ice. Ice is rarely the same thickness across a body of water and changes often. Always check the ice thickness and be sure to avoid areas that have cracks or moving water. Wear bright/reflective clothing so you can be seen, especially at night. We also ask that those operating snowmobiles, ATV's, golf carts, etc., use extra caution on the lake and be aware of those enjoying the many activities mentioned. Please use your lights when operating at night and when visibility is restricted. For those that may be new to the community, the lake, parks and beaches are for members of the FLCA. All guests must be accompanied by a member if using any of the facilities.
